ELECTRONIC VOTING INSTRUCTIONS

EGPOA Members now vote primarily ONLINE – for director elections, our annual operating budget, bylaws amendments, and all other items requiring a Member vote under our By-Laws. This is a safe and efficient method to increase participation while saving both time and money. Earlier in 2024, we launched our electronic voting platform using a third-party representative, called Vote HOA Now.

All Members – including those who previously voted electronically – will need follow an invitation through Vote HOA Now for this vote.

Each Member property with an email on file should have received an email invitation to vote from the EGPOA voting site. Please be sure to add this email address (<u>emeraldgreen@ivotehoa.com</u>) to your safe sender list/address book so you can

participate in the vote. If we do not have your email address on file with EGPOA or you do not receive the email invitation <u>by November 7, 2024</u>, please contact the Management Office (Brittany Cunningham) to update your records or get your code. To vote, there are THREE SIMPLE STEPS:

- 1. Receive the email and click the link to go to the voting site (or go to the voting site and enter your code)
- 2. Register for the vote by entering your name, email, and creating a password
- 3. Make your choices on the ballot and submit

When your vote is complete, you will receive both an onscreen confirmation and an email that the vote has been recorded. The entire process takes only a few minutes - less time than it did to read these instructions!

NOTE: A PAPER BALLOT WILL BE ISSUED <u>ONLY</u> TO THOSE WHO REQUEST ONE <u>IN PERSON AT THE MANAGEMENT OFFICE</u> ON OR BEFORE FRIDAY, NOVEMBER 15, 2024 AT 4:00pm EST. ANY PAPER BALLOT MUST BE RETURNED TO THE MANAGEMENT OFFICE OR CAST IN PERSON AT THE NOVEMBER 17, 2024 SECOND ANNUAL MEETING.
