## 1. CALL TO ORDER

a. Second Annual Meeting and 2025 Operating Budget Vote.

- i. Appointment of Article V, Section 6 inspectors/vote counters
  - 1. Bob Ernst and Linda Chrisey
- ii. Budget vote results
  - 1. The proposed 2025 operating budget was approved with 196.5 votes in favor and 81.5 votes against.
- b. Approval of the 10/20/24 regular meeting minutes. Ilana motioned, Joel seconded, motion approved by voice vote.

#### 3. MANAGEMENT REPORT

- a. Vote HOA Now renewal. Patrick asked for a \$1425 authorization. Beverly motioned, Tom seconded, motion passed by voice vote.
- b. Skid Steer Rental ratification of Board email vote for \$864 from Monticello Rental. Lesli motioned, Joel seconded, motion ratified. Michael noted he utilized a different vendor for less money.
- c. Permit Applications
  - i. 8 Dartmouth Ct. (shed). Chris motioned to approve, Beverly seconded, motion passed by voice vote.
  - ii. 29 Kent St. (tree removal). Earl motioned, Lesli seconded, motion approved by voice vote. Joel abstained.
- d. Permit application review process. The Board discussed concerns expressed about the permit approval process.

## 4. FINANCIAL REVIEW (Joel)

- a. Sept. 2024 Financials. Ilana motioned, Patrick seconded, motion passed by voice vote. Lesli abstained.
- b. Ilana motioned to redact names in the variance report, Joel seconded, motion passed by voice vote.
- c. Patrick expressed concern about aged receivables. Joel said he would develop a formal policy to bring aged receivables (violations, etc.) to the Board in executive session.
- d. Oct. 2024 Financials. Joel motioned, Patrick seconded, motion passed by voice vote.
- e. 2024 operating budget shortfall. Chris said that a data entry error in the approved 2025 operating budget inflated EGPOA's projected non-dues income by \$21,381. Line 4134 (Interests and Dividends) should have been budgeted at \$2,100. Instead, the number entered was \$23,481. This discrepancy also lowered the calculated member dues in the proposed operating budget approved by the members. In other words, EGPOA will take in less dues income than it needs. Chris motioned to allocate \$21,381 from the proceeds of the 90 N. Emerald sale, effectively returning a portion of that sale directly to the homeowners. Joel and Dan seconded the motion, which passed by voice vote.

a. Bob discussed the water tank proposal.
